**Declaration:** I agree to be bound by the 2005-2008 Racing Rules of the International Sailing Federation, the Prescriptions and Special Regulations of Yachting Australia and the current sailing instructions published by the Balmain Sailing Club. If at any time during the year I fail to meet this regulation, the club is entitled to ask me to remove my boat from the Balmain Sailing Club. I understand that if storage fees have not been paid within 4 weeks of acceptance of storage application or renewal date I will be asked to remove my boat from the Balmain Sailing Club.

If storing my dinghy at the club, I agree to abide by the Conditions of Storage as set out in the BSC Sailing Instructions 2006/2007. I understand that all storage is at the owner's risk and that there is **NO** club insurance for stored craft and the club can therefore take no responsibility for craft or equipment.

**Persons must not store or leave outboard motors, fuels, paints, resins, hardeners, thinners, accelerants or other flammable materials in the club premises.**
